There are 5 questions on Mentoring for Leadership Year-end Report. Here are some things to remember and consider when filling out this program report:

Question #1: I imagine that most members present at your meetings and working on your programs have been mentors to your auxiliary – both returning members and more recent members who have been helpful. Take a count!

Question #2: All auxiliaries have been asked for several years to work on promoting a team for mentoring and I know that it could be informally or just individuals working to provide assistance within the organization.

Question #3: Mentoring at the VFW Auxiliary – Relationship Building for the Future materials were handed out at fall Conference to all attendees as well as copies of several other tools to use, such as the acronyms and Terminology documents, for example. IF you were there, you were part of a training session also and received material available from Dept. Chairman Sonia.

Question #4: Many resources were provided to District Chairmen for Schools of Instruction at District Meetings where they shared many more tools that came from our National website and Dept. Chr. Legislative March 2021

Well, here we are in March! Hoping all have developed a teaching strategy on how Legislation works, looking forward to receiving many new ideas and trying to judge the best! You still have time, there is the last of February and two weeks in March! Be sure to attach to your year-end report anything you have done for the Legislative program. Fill out reports completely, do not leave anything blank.

Locally for the State of Minnesota, I have received the following information concerning the **Veterans Restorative Justice Act. (SF 116)** The Senate has passed on to the Judiciary Committee on their side. If there are any stumbling blocks this is likely where they will occur.

On the House side, the **Veterans Restorative Justice Act, (HR 478)** will be carried to the floor by Sandra Feist, 41 B MN House.

Rob Eklund is in consultation with an attorney which is Sandra Feist to help with judicial issues on the House issues of the bill.

The above information was received from Rob Eklund, (DFL) District: 03A, Chair for Labor, Industry, Veterans and Military Affairs Finance and Policy Agricultural Finance and Policy.

Senator Limmer is the Chair of the Senate Judiciary Committee, please contact him and urge him to expedite and schedule a hearing for the **Veterans Restorative Justice Act**. This very worthy bill which helps Veterans that have become involved in the criminal justice system to take responsibility for their problems. This program also helps with other programs that helps the Veterans and their families, jobs, health care, medications, addiction issue, homeless issue, arranging for much needed treatment for Veterans and families if needed. Mentors are assigned to the Veteran for additional support. These Mentors are also Veterans. This bill will also save the Minnesota taxpayers money and this bill will ensure that the Veteran is taken care of by the VA and reducing time spent in jail. Please share to help this bill pass. **Remember to be concise and polite, remember who we represent.**
